Our usual fee for this type of performance is an **honorarium with a 20% non-refundable deposit plus all traveling expenses (meals, lodging, fuel, plane tickets, etc.)**. The amount of the honorarium will be determined according to traveling distance from Montgomery, Alabama to the venue, and should be negotiated via phone (334-260-3739) or email ([egwin95@hotmail.com](mailto:egwin95@hotmail.com)). Deposit is due upon return of this contract. *All checks/ wages should be paid to the order of Eric Gwin.*
